Registration and Allocation

- Students will be registered by CVC manager onsite.
- Allocation of beneficiary (Both new and already registered) will be done by CVC manager.
- CVC manager will check inclusion criteria for HCW , FLW and Citizen as per government norms and allow vaccination.
- MO incharge will check exclusion criteria (Contraindications) as per government norms and fill up declaration form duly signed by beneficiary and countersigned by MO incharge. They will handover this form to beneficiary.



Billing

- Billing officer will create bill based on declaration form (which allows the beneficiary to take vaccine) and hand over the bill to the beneficiary.
- Govt prescribed rate for private CVC is Rs 250/ dose for any kind of beneficiaries from which Rs 150/dose will be submitted to Govt of India and Rs 100 will be shar of Private CVC as procedural charge and other expenses.
- However students (medical, nursing, paramedical) and interns (batch 2020-2021) will receive Rs 100 concession and pay only Rs 150/dose.



Verification and Vaccination

- Verification will be done by vaccination officer No. 2 after seeing bill and declaration form for alloted beneficiaries for the session. He/ she will collect the declaration form for future reference and maintain registers according to Govt norms.
- Vaccination will be given by Vaccinator for verified beneficiaries and vaccinated beneficiaries will be followed up in Observation room by Vaccination officer No. 3 and 4 for AEFI. In case of any AEFI, institituional AEFI management committee will manage the case after providing initial first aid by vaccination officer 3 /4 or vaccinator. CVC manager and vaccination officer 2 should be informed regarding the AEFI for reporting in the govt portal from their side.
