Sub.- Recognition/Approval of IQ City Medical College, Burdwan, West Bengal for the award of MBBS degree (150 seats) granted by The West Bengal University of Health Sciences, Kolkata u/s 11(2) of the IMC Act, 1956.

Sir,

I am directed to inform you that the assessments to assess the standard of examination held by The West Bengal University of Health Sciences, Kolkata and to assess the physical and the other teaching facilities available for Recognition/Approval of IQ City Medical College, Burdwan, West Bengal for the award of MBBS degree (150 seats) granted by The West Bengal University of Health Sciences, Kolkata u/s 11(2) of the IMC Act, 1956 were carried out by the Council assessors on 6th February, 2018 and 7th & 8th March, 2018. The assessment reports (6th February, 2018 and 7th & 8th March, 2018) were considered by the Executive Committee of the Council at its meeting held on 24/03/2018 and it was decided as under:-

"The Executive Committee of the Council considered the assessment reports (06th February and 7th & 8th March, 2018) and decided to recommend to the Central Government for recognition/approval of IQ City Medical College, Burdwan, West Bengal for the award of MBBS degree (150 seats) granted by The West Bengal University of Health Sciences, Kolkata u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 28.03.2018.

In view of above, you are, therefore, requested to issue necessary notification at the earliest recognizing IQ City Medical College, Burdwan, West Bengal for the award of MBBS degree when granted on or after Feb., 2018 by West Bengal University of Health Sciences, Kolkata.

A copy of the assessment report is enclosed herewith.
