

- iv) DRP students going for academic paper presentation during their DRP period must submit their Paper related details & date of presentation duly forwarded by the respective HoD & Dean of Students Affairs to the respective Superintendent at least 15 days before the said presentation date.

Guidelines of District Residency Program (DRP)

Annexure-I


- District Residency Program as per NMC (National Medical Commission) through India Gazette Notification, is going to be implemented all over the state from the upcoming session wherein the 3rd, 4th, and 5th semester PG students will be posted at district level hospitals for the purpose of public health & health system orientation.
 - It will be tried to be completed the 3 months DRP tenure preferably within the 3rd and 4th semester i.e. 1st part of the 2nd year PG Courses maximum within 3rd quarter i.e. 9 months during their 2nd year tenure.
 - All Medical Colleges having Post Graduate Trainees in different disciplines will be linked with remaining Districts at their District Hospitals, Sub Div. Hospital, State General Hospital and Super specialty Hospital all over the state having Sanctioned Bed No. More than 100. *This is to be mentioned that majority of the District Hospitals have been converted to Govt. Medical Colleges but if the PGT posted there under DRP program will be given credit as DRP exposure as these institutions still granted as District Level Hospital exposure under NMC notification vide: F No. NMC/23(1)(25)/2021/Med/001866 dated:19.01.2023.*
 - One Medical College may have links with multiple District Level Hospitals. Similarly, one DH, SDH SGH or SSH may be assigned with multiple Medical colleges as per the matrix.
- i) It shall be permissible for the postgraduate students from the North East Zone (NEZ) in various medical colleges / institutions in the country, to undergo District Residency Program in their respective States. [Under pg-8 item (g) vide No. MCI-18(1)/2020-Med./121415, BOARD OF GOVERNORS IN SUPERSESSON OF MEDICAL COUNCIL OF INDIA NOTIFICATION New Delhi, the 16th September, 2020]. In that case, a letter of NOC from the competent authority of District Level Hospital from their state giving permission for DRP posting of that candidate in the domicile state along with valid Id with residential proof and a letter addressing to the DME, H & FW, Govt. of West Bengal through proper channel mentioning details are required to be submitted. Stipend shall be provided to the said candidate only if attendance duly authenticated by the State authorities where they propose to do the DRP is received on time to the parent Medical College. The Medical College shall not be



responsible if the said candidate does not satisfy the NMC norms to be achieved in DRP in their chosen State.


- The matrix of their posting may be over lapping and multiplication may occur, so the nodal officer/ Single Point of Contact (SPC) / DRPC (District Residency Program Coordinator) persons will be most responsible for conducting the network successfully.

- It was decided that the Deputy CMOH-I of the concerned district is the Nodal person who will coordinate the assignment and posting of the medical Students (PGTs) of the assigned medical colleges in different DH/ SDH/ SSH s under his/ her district.
- On the other side, at the end of the PG medical Institute, Dean of Student affairs will act as the Nodal Person, who shall coordinate placement of the PG students to different districts attached to his/ her PG Medical Institution.
- The preference will be given that, The Post Graduate Trainee will be placed nearer to their Parent Medical College and at least 2/4/6 like even number of PGTs from same disciplines of same medical colleges will be maintained during their posting at same district level Hospitals to be utilized in;
 - i) Concerned /aligned specialty team/unit at the District level hospital and will be trained under the overall guidance of the District Specialists. They will work under the overall directions and supervision of the DRPC. The clinical responsibilities assigned to the Residents would include serving in outpatient (OPD), Inpatient, Casualty and other areas and encompass night duties.


- ii) One third of their 3(three) months of posting (i.e. One month) their posting may be placed such a way that they can get exposed to existing National Health Program operationalized.
 - iii) As there are residential accommodation crisis in different district and sub district level hospitals, preferably the students should be placed nearer health facilities initially.
- Pre/Para clinical along with Community Medicine like discipline preferably will be linked or assigned with district health program running under National health program. They also need to be placed /or involved in the field level program delivery under supervision.
 - PGTs of Clinical disciplines will be posted /or assigned according to their concerned department and services. Or as per the curriculum provided by NMC from time to time.
 - Any services assigned to the students always should be under supervision and /facilitation by the concerned authority. They will never be left unsupervised and not to be placed as when necessary based patient care services like locum tenancy/replacement duty etc.
 - Leave rules will be applicable as per Post Graduate Training curriculum as mandated by the West Bengal University of Health Sciences, Govt. of West Bengal.
 - Separate attendance will be maintained at the place of posting (Secondary tier Hospitals) and based on that stipend /salary will be provided by the parent medical college from where they are posted.

MONITORING & SUPERVISION

- I. Course coordinator of the said program at the District end (Deputy CMOH-I) will regularly monitor their activities as per curriculum, and then s/he will report to the concerned nodal person of the respective Medical Colleges.
- II. Completion Certificate will be given by the course coordinator at the District i.e. Deputy CMOH-I.
- III. The log book will be signed by the Deputy CMOH-I and subsequently counter signed by Dean of Students' affair of the concerned Medical College.



- IV. One additional official like Assistant Dean or any other responsible person may be designated by Dean or Principal of the Medical College to look after by keeping in touch with and do liaison with Deputy CMOH-I of the place of posting.
- A team from working group/committee recommended by Directorate of Medical Education may visit periodically to monitor the overall program.
 - The opinion, feedback from HoD and Other senior faculty member of the concerned department will be reviewed Time to time.
